

DO YOU NEED A STATE PERMIT?

Following is a partial listing of projects which may require permits from the Agency of Natural Resources and telephone numbers for Regional Offices. This is not a complete listing of permitting requirements. Copies of the Permit Handbook are available from the Environmental Assistance Division at 241-3456.

***Water Supply and Wastewater Disposal Permits:** As of July 1, 2007, Water Supply and Wastewater Disposal Permits are issued through the State of Vermont, Environmental Protection Division of the Agency of Natural Resources. You may contact the State Waste Water Management Division at 476-0194 to answer questions. You will need an engineer/site technician to design your water supply and wastewater disposal system. **A copy of the state permit and a copy of the engineer/site technician's system design is required at the time your Application for Zoning Permit is received by the town.**

***Act 250:** In addition to projects described above, an Act 250 permit may also be required for projects such as five or more lots of land of any size subdivided within five years, five or more dwelling units, commercial projects depending upon the size of land on which they are located, logging or any construction above 2500', municipal projects involving more than ten acres, substantial or material changes to previously permitted pre-existing projects. To determine whether or not you need a permit, please call your Regional Office for a Project Review Sheet from a District Coordinator. 476-0195 or 476-0185.

*Floor drains, water systems, bottling water - call 241-3400 to see if you need a permit.

*Industrial process, air emissions, open burning, burning waste oil, call 241-3840 to see if you need a permit.

*Stormwater disposal, call 241-3770 to see if you need a permit.

*Wetlands, stream alterations, shoreland construction, call 241-3770 to see if you need a permit.

*Waste transfer stations call 241-3444 to see if you need a permit.

*Hazardous waste handling, storage, treatment, transportation, call 241-3888 to see if you need a permit.

*Construction permit for fire prevention, electrical wiring, plumbing and access, boilers and pressure vessels and LP gas storage - call Department of Labor and Industry at 479-4434 to see if you need a permit.

*Food, lodging, bakeries, children's camps, asbestos and lead control program - call the Department of Health at 800-439-8550 to see if you need a permit.

*Greenhouses, golf courses, milk processing, poultry processing, pesticides, weights and measures, slaughterhouses, animal shelters, kennels, retail sales of milk, meat, poultry, oleo, pesticides, call Department of Agriculture at 828-2500 to see if you need a permit.

*Construction within a state highway right-of-way call Agency of Transportation at 828-2653, junkyards call 828-2049, off-premise signs call 828-2651.

*Child care facilities call Agency of Human Services at 241-2158.

*Nursing and other care homes call Agency of Human Services at 241-2345.

*For Business Registration call the Secretary of State at 828-2366.
